

GETTING STARTED

- 1. Before first use, charge your device for approximately 2 hours. The USB charging cable can be plugged into any USB port or USB / AC power adapter (not included).
- · Charging = LED Light Flashing
- Charged = LED Light Solid



- 2. Wash your device with soap and water, or toy cleaner suitable for use with silicone items.
- 3. Lubricate your device (if needed) with a water-based, silicone compatible lubricant.






4. Our products are designed to be splash-proof. Your device can be used in the shower and can be run under water in the sink to be cleaned. Never immerse your device in water.

TRAVEL LOCK

To enable the travel lock, press and hold the 🖰 button for 3 seconds while the device is off. The LED-indicator will flash twice indicating that the device is locked.

To disable the travel lock, press and hold both the \circlearrowleft button for 3 seconds. The LED-indicator will flash twice indicating that the device is now unlocked and ready for
